4. Details of our assessment

Linda Warrick visited the site with Elaine Gunstone. We arrived on site at 13:35. We were met by Mike Palmer the MD and Darren Jones the TCM. The weather was grey and overcast. It had been raining and hail stoning earlier in the day so the ground was wet. The visit was part of the South West Waste Teams routine inspections.

We spent some time in the office discussing hazardous waste consignment notes and Mobile services. I forwarded DJ NRW's current guidance on Mobile services for the sites records .LW looked through some consignment notes which were all signed dated and filled in correctly.

LW checked the most recent 14001 Audit which was up to date. The monthly air tests undertaken by Anchem were also looked at and the results were all well below the threshold levels.

Darren Jones the sites TCM had booked in for his continuing competency test. This has been completed and is valid until the 29th of November 2025.

DJ took LW and EG to the permitted storage area. There are 2 10 tonne asbestos containers there. Only one is used at any one time to ensure the permit quantities are complied with. They are both located within the building which is secure and well maintained. The housekeeping at the site is excellent. LW checked the service date on the H type vacuum cleaner which forms part of the spill kit. The service date was expiring the following day. This has been completed and is now up to date. All the vehicles used for the collection of asbestos have fully kitted out spill kits and H type vacuum cleaners.

LW discussed the changes to legislation that will prevent permitted sites registering exemptions and it may be possible to add list of wastes to the current permit at a later date. LW stated that Pheonix will receive a letter in due course explaining the changes and the options available to them.
