As part of Natural Resources Wales' (NRW) routine assessments for compliance, the Continuing Competence of the Technically Competent Manager (TCM) at Rhydeinon HWRC was reviewed. During this review, the latest Continuing Competence certificate of Mark Saunders, Tina Morris and Liane Timmermann, the site's TCMs, were found to be in date, with expiry dates of the 12th of January 2024, the 10th of January 2024, and the 13th

of January 2024. No further action is therefore required.
