Introductory note

This introductory note does not form a part of the notice.

The following notice gives notice of the variation and consolidation of an environmental permit.

This variation incorporates two additional point source emissions to air (the first from the main dust unit emission stack and the second from the blend bins emission stack) into the permit. This variation retrospectively incorporates the two previously unpermitted emission points into the permit, to reflect current site operations. Both emission points have cartridge filters fitted. The variation also corrects a typographical error within Table S1.1 and removes reference to the storage of red diesel, which no longer takes place on site. Table S1.3 has been updated to reference IC6 as complete.

Schedule 3(a) and Schedule 4(a) have been deleted as the effective date has since expired and emissions and monitoring referenced within these schedules are no longer applicable.

The rest of the installation is unchanged and continues to be operated as stated in the permit.

The schedules specify the changes made to the permit. Schedule 1 of the notice specifies the conditions that have been varied and Schedule 2 comprises a consolidated permit which reflects the changes being made.
