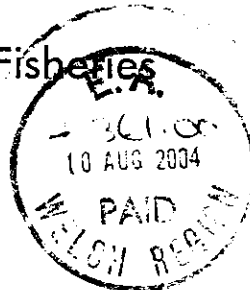

**WATER RESOURCES ACT 1991 (AS AMENDED)
USE OF MALACHITE GREEN**

As you will be aware Malachite Green is no longer available as an anti-fungal agent for use in aquaculture. In consequence the Secretary of State for Environment, Food and Rural Affairs has Directed the Agency to remove any permissions for discharge of that substance to controlled waters.

Your consent Number CM0231502 does not include a specific permission to discharge Malachite Green, but it does include a requirement for you to obtain the prior agreement of the Agency for the use of any chemicals that could present in any discharge. Under this condition the Agency specifically prohibits the use of Malachite Green at your fish farm. As a consequence of this notification you must immediately cease any discharge of Malachite Green.

The Agency recognises the need for use of anti-fungal agents. On a temporary basis to allow you to continue your business we are prepared to permit the presence in your effluent of substitute fungicides, subject to your strict adherence to manufacturers guidance and any guidance or instruction from other regulators such as Veterinary Medicines Directorate (VMD) and Food Standards Agency (FSA). This permission to use substitute fungicides shall remain effective only until such time as the Agency agrees your use of chemicals, as set out below. Further use of any chemicals after that time must only be made in accordance with the terms of the consent conditions.

Where the substitute is Pyceze, (bronopol), your strict adherence to the manufacturer's guidelines is expected to be sufficient to protect the environment and you may for the time being discharge the resultant effluent in admixture with your normal effluent, maximising its dilution as far as possible.

You will note that your consent requires the prior agreement of the Agency to the use of all therapeutic and prophylactic chemicals on your fish farm. The Agency has adopted this prior approval requirement as a more flexible and effective regulation of discharges of such chemicals to the environment than limiting concentrations in the discharge. The approval will be a continuing agreement to specified chemicals in your effluent dependant on the specific method of use on your site. Note that the use of

therapeutic and prophylactic chemicals for the treatment and husbandry of fish is a matter for VMD and FSA. You will not be required to seek agreement of the Agency for each occasion you wish to use agreed chemical treatments in accordance with your plan. These chemicals have the potential to affect the receiving watercourse and the Agency's aim is to ensure that your proposed use will not have any off-site effects.

However, this requirement will not prevent your use of therapeutic chemicals during the period from now until such time as the Agency agrees your proposed use. Provided you apply for approval, as set out below, the Agency agrees to your continued use of all current chemicals (except Malachite Green) for a period of six months from the date of this letter or until you receive Agency approval of your plan, whichever is the sooner.

You will need to seek agreement from the Agency for the presence in your effluent of any chemicals that you currently use either regularly or occasionally. To implement this process you should prepare a plan of your proposed usage of substitute fungicides and any other chemical treatments that you may wish to use on your site. These details should include the chemicals (trade name and active ingredients) you propose to use, how they will be used on your site (concentrations, location, etc) and how you propose to dispose of the chemical after use. For instance, the likely concentration of chemical in any treatment tank and its planned rate of flow into your final discharge flow. This plan should be sent to me at the address below by 14th July 2002. If the Agency is satisfied that your proposed use plan poses negligible risk to the environment then we will write to confirm that you may continue use according to your plan. If we are not satisfied then the Agency may request changes in your plan, and you will then be required to comply with those changes. Any such changes will normally be required only after discussion with you.

We expect that in the majority of cases it will not be necessary for us to impose numeric limits on prophylactic and therapeutic chemicals. However, we reserve the right to do so. If in the future you wish to change the chemicals that you use or the way you use them you must write to the Agency asking for agreement to the change in your plan. The Agency reminds you that using any chemicals other than in accordance with the conditions of your consent is an offence and may result in enforcement action. Our aim is to ensure that no discharges adversely affect the environment and to be able to demonstrate this to other river users. I am sure that as a river user you support this aim.

These changes will not affect your present liability to annual discharge charges. If you have any questions please contact me as soon as possible at the address below.

USE OF MALACHITE GREEN IN FISH HATCHERIES AND FARMS

The above fungicide was prohibited for use on food producing animals by UK regulations enforcing EC Regulation 2377/90. Notwithstanding this it has continued in widespread use. The EC has now required its immediate withdrawal. The Government is taking steps through Veterinary Medicines Directorate and Food Standards Agency to ensure that it does not enter the food chain. The Agency also needs to take action in relation to discharge consents.

Our position is that the Agency will serve Notices on fish farm consent holders preventing discharge of Malachite Green. We will facilitate the use of substitutes through legally correct and environmentally protective consents.

The Agency has issued around 340 fish farm consents, most of them specifying discharge limits for Malachite Green. To ensure prevention of use DEFRA has directed the Agency to identify all consents to remove explicit or implicit authorisation for discharge of the substance. A copy of the Direction is attached.

Now that we have received the Direction Regions will need to move quickly to serve Modification notices on relevant dischargers. The Direction was received at Head Office on the afternoon of Monday 10 June 2002. We should aim to have served all relevant Notices by the end of the week of receipt of the Direction, and to have established the "Prior Approval" procedure (see below) within a month.

To facilitate this a standard covering letter and Notice of Modification have been drafted, reflecting the wording that we received in the Direction. Copies are attached.

Our intended long term approach to use of therapeutic and prophylactic chemicals is to require our prior approval of use of such chemicals, but in a way that avoids the need for numeric consent conditions in most cases. We also intend to add a "fish farm operation"

condition, which emphasises the responsibility of the operator to work in a way that minimises risk of pollution.

In the short term we will allow the continued use of substitute fungicides, pending the application for prior approval.

Regions have previously provided information to Head Office from the Charging database on the names and addresses of all fish farms. This data is appended as an Excel spreadsheet. Prior to sending the Modification Notice, it will be necessary to check the consent wording for each fish farm. This is because the charging trawl includes some fish establishments (e.g. shellfish depuration) where use of Malachite Green is not likely to be currently permitted.

Guidance to consenting staff on the information necessary for prior approval for use and/or discharge of Pyceze or other alternatives will be issued shortly via the Discharge Control Process.

Additionally we will also need to ensure that our own hatcheries and fish rearing establishments are conforming to Government policy.

MODIFICATION OF CONDITIONS OF CONSENT - MALACHITE GREEN**

Following recent events in respect of the letter from the Commission informing the UK to stop the use of malachite green to treat farmed salmon and trout, it is necessary to modify existing fish farm consents to reflect that decision. I am therefore attaching a Direction from the Secretary of State for the Environment, Food and Rural Affairs instructing the Environment Agency to modify conditions in fish farm consents where the discharge of malachite green is made to controlled waters.

I would be grateful if the Agency could now implement the Secretary of State's Direction as appropriate.

MODIFICATION OF CONDITIONS OF CONSENT UNDER CHAPTER II OF PART III
OF THE WATER RESOURCES ACT 1991 (AS AMENDED BY THE ENVIRONMENT
ACT 1995)

The Secretary of State, in exercise of her powers conferred on her by paragraph 7(4) of Schedule 10 to the Water Resources Act 1991, hereby directs the Environment Agency ("the Agency") to modify the conditions in respect of all relevant consents currently in force for the discharge of trade effluent from fish farms where concentrations of Malachite Green are discharged to controlled waters.

The Secretary of State further directs that the Agency shall modify such consents to discharge by:

- a) deleting any condition setting numeric effluent limits for any of the following substances:
 - malachite green
 - copper as Cu
 - monohydric phenol as C_6H_5OH
 - formaldehyde, and
- b) where appropriate, replacing any such condition(s) to reflect the following requirements:
 - "The Consent Holder shall not use any prophylactic or therapeutic chemicals on the farm in such a way that they could be present in the effluent, unless the use and possible presence in the effluent of the materials has the prior written agreement of the Agency. The Consent Holder shall comply with any conditions relating to their use and/or discharge required by the Agency and shall keep a specified record of use and/or discharge available for inspection by the Agency.
 - Farm Operation Condition
 - (i) The farm shall be operated and effluent shall be treated in a manner which, so far as reasonably practicable, minimises the polluting effects of the Discharge made from the farm on controlled waters.
 - (ii) This condition does not require:
 - (a) any higher standard to be achieved in relation to any characteristics of the discharge which is specifically regulated by numeric quality condition(s) of this consent than is required by that condition/those conditions;
 - (b) any alteration of the farm or a change in the type of treatment used".

CONDITIONS OF CONSENT TO DISCHARGE

Fish Farm Effluent ("the Discharge")

FROM: Seven Springs Trout Farm

1. (a) The Discharge shall not contain any poisonous, noxious or polluting matter or solid waste matter.
- (b) Provided that the Discharge hereby consented is made in accordance with the following condition of this consent, such discharge shall not be taken to be in breach of condition (a) above by reason of containing substances or having properties identified in and controlled by those conditions.

NATURE

2. The Discharge shall consist solely of trade effluent comprising fish farm effluent.

LOCATION

3. The Discharge shall be made in the manner and at the place specified as :
 - (a) discharging via a pipe from a settlement pond;
 - (b) discharging to an un-named tributary of the River Wheeler;
 - (c) at National Grid Reference SJ 1337 7280;
 - (d) shown marked "Discharge Point" on plan CM0231502 attached as Annex 1.

SAMPLING POINTS

4. The inlet to the fish farm and the outlet to the watercourse shall be maintained so that;
 - (a) representative samples of the inlet water may be obtained at National Grid Reference SJ 1335 7304 as shown marked "Inlet Sampling Point" on plan CM0231502; and

(b) representative samples of the Discharge may be obtained at National Grid Reference SJ 1337 7280 as shown marked "Discharge Point" on plan CM0231502.

VOLUME

5. The volume of the Discharge shall not exceed 5700 cubic metres per day.

COMPOSITION

6. Passage of water through the fish farm as measured by difference in composition between samples of the inlet water to the fish farm taken at National Grid Reference SJ 1335 7304 and the Discharge shall not increase:

- (i) the biochemical oxygen demand (measured after 5 days at 20°C with nitrification suppressed by the addition of allyl-thiourea) by more than 2 milligrammes per litre;
- (ii) the ammoniacal nitrogen (expressed as N) by more than 0.5 milligrammes per litre;
- (iii) the concentration of suspended solids (measured after drying at 105°C) by more than 25 milligrammes per litre;
- (iv) the pH shall not be changed by more than 0.5 pH units.

7. The pH of the Discharge shall not be less than 6 or greater than 9 pH units.

8. The Discharge shall have a dissolved oxygen concentration of greater than 7 milligrammes per litre.

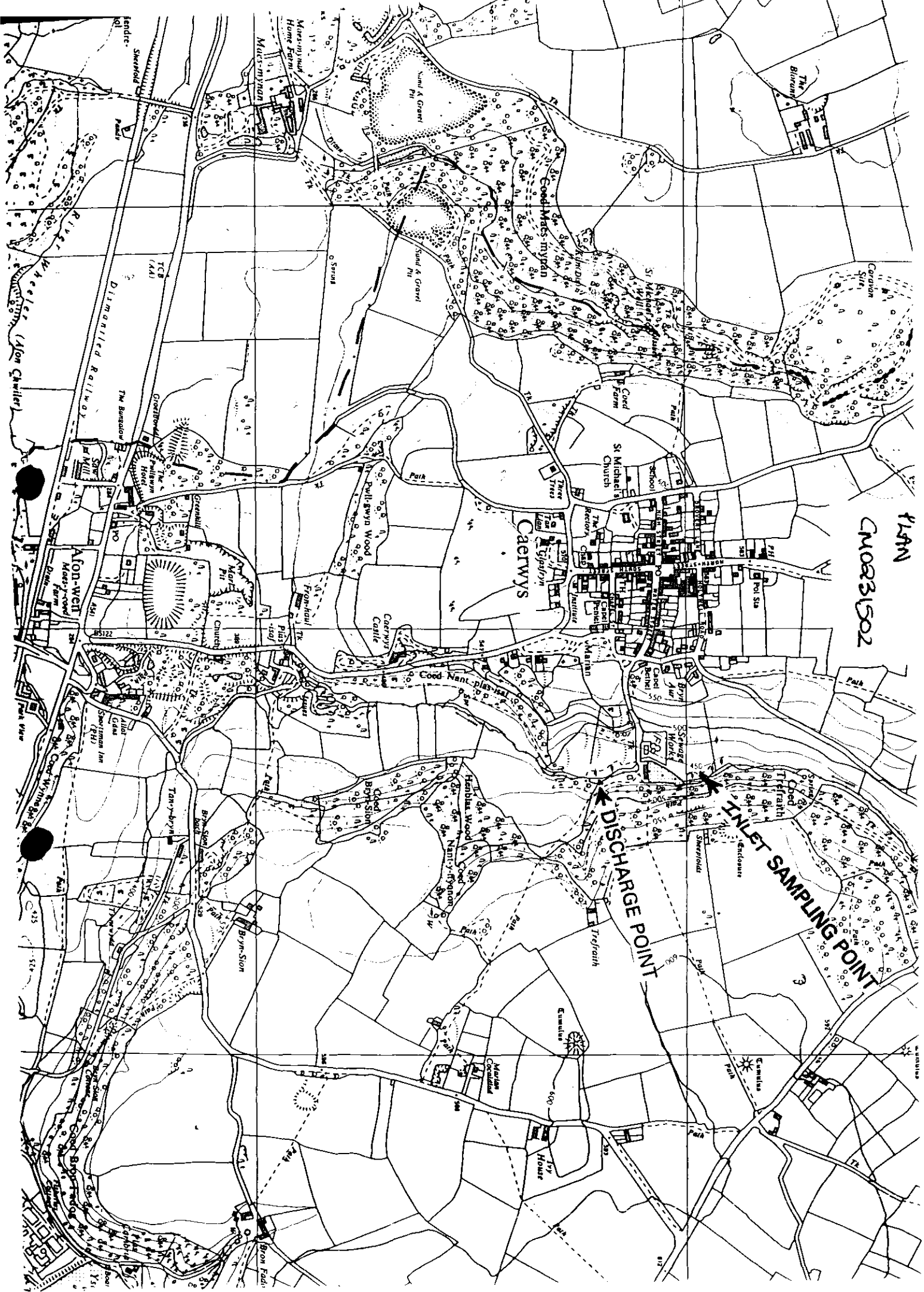
9. The Agency shall be notified prior to any chemical treatment being used for medicinal or other purposes within the fish farm. The Agency's approval in writing must be obtained before use commences.

10. As far as is reasonably practicable, the fish farm shall be operated so as to prevent:

- (a) any matter being present in the Discharge, other than matter specifically covered by numerical conditions in this consent, to such an extent as to cause the receiving waters, or any other waters of which the receiving waters are a tributary, to be poisonous or injurious to fish in those waters, or others cause damage to the ecology of those waters; and



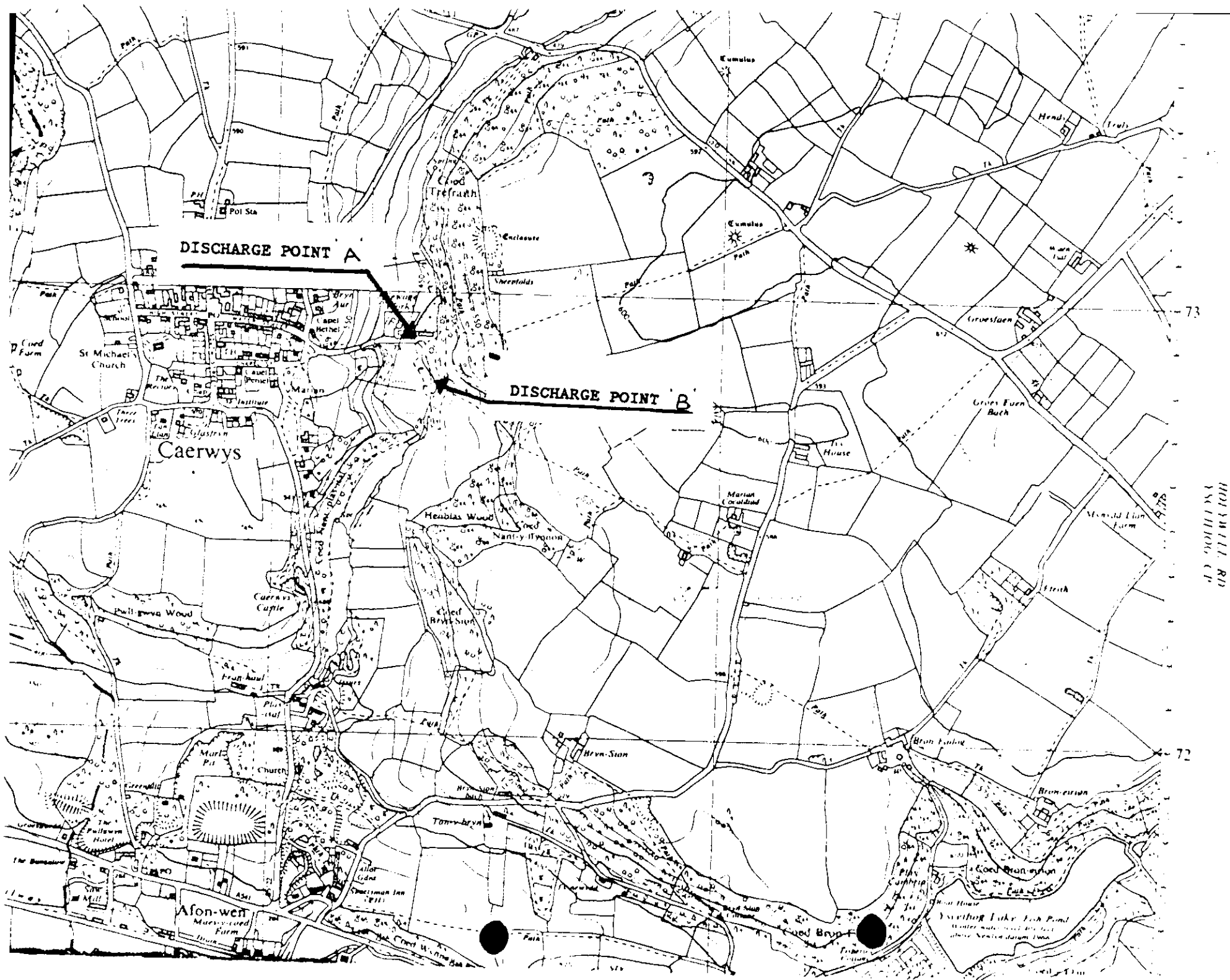
