4. Details of our assessment

LW attended site on the 19th of October. Pete Jones is currently action TCM. PJ has an up to date CC COTC. The weather was overcast. LW and PJ had a discussion regarding the consignment notes LW asked for PJ to forward a sample of these. PJ forwarded these on the 6th of November.

Consignment Notes forwarded only specify number of sharps boxes or number of clinical bags. There is no KG quantity noted. Please ensure this is completed on future notes. The notes had the correct premise code and were all dated and signed.

Black bag waste being removed by Griffiths had the incorrect EWC code 17 05 04 which is a Mirror Non hazardous entry for soil and stones. PJ picked this up and this was in the process of being resolved with Griffiths. Please provide feedback on the corrective action by the 12th of January.

Please provide details of any exemptions registered for the site by the 12th of January.

Consignee returns are now in place and they are all up to date.

Dual coding is still not being used on consignment notes for medicinally contaminated sharps. This could cause onwards problems with treatment facilities that have not got the appropriate abatement. Please ensure this is in place for any new movements of waste meeting this description.

LW and PJ walked down to the permitted storage area. The clinical waste storage is located in a locked secure compound. The euro carts were all locked and tagged. Orange lidded sharps boxes were not dated and this needs to be addressed by staff training.
