## 4. Details of our assessment

On the 8<sup>th</sup> November 2023 you informed us via an early warning that Scurlage sewage pumping station was in hydraulic overload when the weather conditions had been dry. This report was upgraded to a self-reported incident on the 9<sup>th</sup> November when it was identified that the SPS was discharging storm effluent from its emergency overflow into a nearby ditch. By this time there had been heavy rainfall.

Discharging storm sewage from Scurlage SPS is in breach of Condition 1 of the permit emergency overflow permit in place which states that the discharge shall consist solely of sewage in an emergency.

This breach is in contravention of Regulation 38 (2) of the Environmental Permitting (England and Wales) Regulations 2016 which states that it is an offence for a person to fail to comply with or to contravene an environmental permit condition.
