4. Details of our assessment

Natural Resources Wales senior industry and waste regulation officers Carter Shone and Phil Harper visited J Reid Trading Ltd on the 30th of November 2023. This was a pre-arranged familiarisation visit and site inspection accompanied by the waste manager.

At the time of the inspection the site was operational.

Weather conditions cold but clear day.

Permitted activity

After a meeting to discuss any changes and future plans we were provided a full tour of the facility.

The incoming waste refrigerant was clearly marked in separate bays.

Other waste gasses including cylinders were clearly labelled and stored accordingly.

Any waste oils and other waste liquids were provided with secondary containment, which was visually in good condition and empty of any water.

Hazardous waste was also clearly labelled and stored in secure locked containers

The site

The site was in good condition; it was clean and tidy with no damage to the Impermeable surface being observed.

No odours were noted during the inspection.

Offsite noise was not deemed to be excessive
