4. Details of our assessment

For clarity, this compliance assessment is being carried out on the 8th December 2023 but relates to the sample taken from the package treatment plant at Caer Mynydd Caravan Park on the 29th November 2023.

The permit limit for suspended solids is 30mg/l. The permit limit is in place to protect the receiving water body.

The sample result was 34.4 mg/l.

Improvements have been made on site to the pipework and package plant and this has been reflected in the most recent results, however, it is still a breach of the permit conditions.

Please check that the surface water drains on site do not feed into the package treatment plant as this will overload the system and reduce the efficiency of the treatment process.
