As part of Natural Resources Wales' (NRW) routine assessments for compliance, the Continuing Competence of the Technically Competent Manager (TCM) at Sychtyn AD Plant was reviewed. During this review, the latest Continuing Competence certificate of Edward Vaughan, the site's TCM, was found to be in date, with an expiry date of the 15th

of February 2025. No further action is therefore required.
