Natural Resources Wales (NRW) Officer Greg GARDNER and Waste Regulation Higher Education Placements Cerys PHILLIPS & Rhiannon MUNRO attended the Tarmac Trading Ltd site at the Llanwern Works Inert Waste Recycling Facility, Queens Way, Llanwern Works, Newport, NP19 4QX for an unannounced routine site inspection at 11:00am. The weather was dry and reasonably cold.

GENERAL OBSERVATIONS

General housekeeping on site was to a good standard with no waste(s) stored outside the permit boundary. There was no offensive odours or excessive noise witnessed by NRW staff as well as very little amounts of airborne dust witnessed. Stockpiles of materials were not deemed unsafe with the hardstanding flooring in good condition. There were areas of pooled water following recent heavy rain however were of no cause for concern during the site inspection. All plant and machinery were non-operational with them being stored in appropriate safe locations on site (see photos 1-3). The site had secure fencing around the perimeter as well as appropriate CCTV in place.
