An unannounced site inspection was carried out on the 06 December 2023 by NRW officer

David Ellar. The officer was unaccompanied around the site. The weather was fine and dry.

Observations:

The site was quiet and well managed, there was not a lot of waste on site but what was there was appropriately stored and segregated. Storage bays were utilised and were well marked. The site was secure and the weighbridge was manned.

No permit breaches or non-compliances were observed during the visit.
