4. Details of our assessment

On the 15th November 2023, routine samples of the discharge from Coleg Gwent Usk Campus Sewage Treatment Works were taken.

BREACH OF DISCHARGE PERMIT CONDITION 3.1 AT COLEG GWENT USK CAMPUS PERMIT NO. AB0082201.

Sample results recorded a breach for Ammonia (permitted value 5mg/L, recorded value 13.3mg/L).

The breach appears to have been related to a failure of the sludge return pump, now repaired.

Please continue to monitor the site and ensure maintenance issues are dealt with in a timely manner.
