Screens have been scheduled for maintenance inside the bathing water season. This is of concern due to the proximity of the outfall to Aberafan beach. Maintenance should be carried out prior to commencement of the bathing water season, where possible.

There is an ongoing issue with the pumps at this site. Over pumping was in place at time of inspection. A long term fix needs to be achieved for the pumps at this site.
