4. Details of our assessment

This CAR form has been re-issued on the 12th of December 2023 and supersedes the CAR form issued on the 29th of June 2023.

This was an unannounced site inspection carried out following a report that the Trade Effluent Services Ltd had commenced spreading activity at the Deployment PAN- 019532 (Plas yn Llan). The inspection was carried out by NRW Officers Boguslawa Pierzchala and Maria Majka.

Officers arrived onsite and met with the spreading contractor. The spreading contractor was not willing to provide his name. The contractor confirmed spreading at the location had commenced the previous day. Spreading was seen to be taking place via injection, as per the permit conditions and was within the agreed timeframe on the deployment application.

During initial checks, a pre-spreading notification could not be located by regulatory officers. Following the inspection it was identified that pre-notification had been submitted on the 05/06/2023 for the period 07/06/2023 - 21/06/2023 by the Trade Effluent Services Ltd to NRW. Due to an internal communication error this was not passed to the Waste Regulation Team.

There was localised odour at the time of the inspection, however this was not deemed excessive at the time.

An information board regarding the permit and who to contact in an emergency was located on one of the storage tanks, as stated in the agreed deployment form, however this information was located at the back of the tanks, which would not be visible to the public should this information be required. An action has been given to ensure the site board is fully visible.

There were no breaches identified as a result of this site inspection.
