4. Details of our assessment

The improvement conditions below were outstanding following the permit variation (V009) resulting from the publication of the BAT Conclusions for the Waste Treatment sector.

"IPC17

BAT 7. Monitor emissions to water

The operator shall submit to Natural Resources Wales (NRW) a written procedure(s) in accordance with requirements specified within BAT Conclusions of the Waste Treatment BREF Document (EU 2018) in relation to:

BAT is to monitor emissions to water with at least the frequency given within table for the relevant treatment type (Treatment of water-based liquid waste), and in accordance with EN standards. If EN standards are not available, BAT is to use ISO, national or other international standards that ensure the provision of data of an equivalent scientific quality, taking into account the table footnotes. Information resulting from this improvement condition will be used to assess the relevance of the BAT AELs and monitoring requirements as set in Schedule 3 and 4 of this permit."

CAR_NRW0042709 details the monitoring that NRW require GD to carry out and the reasons for that decision.

A monitoring procedure "OP-025 Discharge Monitoring Procedure" was received on 8th December 2023. The final version was received on 11th December 2023.

This procedure complies with the requirements of IPC17, which has been completed and can therefore be closed.

A revised S1 form, Emissions to Sewer, was sent to GD on 11th December 2023. This form must be used to report emissions to sewer from 1st January 2024.

"IPC19

BAT 20 Reduce emissions to water

The operator shall submit to Natural Resources Wales a written procedure(s) in accordance with requirements specified within BAT Conclusions of the Waste Treatment BREF Document (EU 2018) in relation to:

BAT 20 - In order to reduce emissions to water, BAT is to treat waste water using an appropriate combination of the techniques described within BAT 20 Table. BAT 20 applies to all sites that treat waste waters on site to reduce emissions prior to discharge.

BAT-associated emission levels (BAT-AELs) for indirect discharges to a receiving water body

should comply with Table 6.2 of BAT 20.

Information resulting from this improvement condition will be used to assess the relevance of the BAT AELs and monitoring requirements as set in Schedules 3 and 4 of this permit."

Waste treatment procedures compliant with IPC19 were received some time ago. This improvement condition has been completed and can therefore be closed.

All the improvement conditions in V009 of the permit have been completed and can therefore be closed.
