The outer bars of the outfall have been cleared of all rag. However, the flap valve behind the bars is still jammed open due to the quantity of rag around it. It is unclear whether the screens have been maintained within the last few years. They are scheduled to be maintained during the bathing water season, which could provide a risk to public health.

The apron in front of the outfall is not fit for purpose. The gabion baskets collect rag which can then be carried away on the following tide. There is a pool of potentially septic effluent at the foot of the apron. Again, this will be mobilised on every high tide.
