A Trigger Exceedance Notification report was received from Dwr Cymru in February 2023 after the number of spills permitted was exceeded on the 14th of January 2023. Then an Initial Investigation Report was submitted on the 3rd of November 2023.

The length of time between the exceedance and the submission of the Initial Investigation Report means that the report arrived late and as such, is a permit breach. A warning is issued via this CAR form for this.

After saying the above, thank you for submitting the Initial Investigation Report.

It's noted that you intend to carry out a feasibility study by the 29th of February 2024.

Please provide an update on this feasibility study (or a Spill Reduction Plan with appropriate timescales) by the 12th of March 2024, i.e. 3 months from the date of this CAR form.
