Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

At this time, we do not intend to take any further action.

This statement does not stop us from taking additional enforcement action if further relevant information comes to light or offences continue.

4. Details of our assessment

Whilst looking at the Initial Investigation Report (i.e. stage 2 report) for this site, it was noted that the Trigger Exceedance Notification (i.e. stage 1 report) received on the 27th of February this year was sent to Natural Resources Wales more than 4 weeks after the number of spills exceeded the limit specified in the permit. The report was received 6 weeks and 2 days after the exceedance. The late submission of the report is a permit breach.

This breach has been classed as a category 4, no potential environmental impact breach, with the enforcement outcome for this instance being advice and guidance. This advice is in the form of reminding Dwr Cymru of the 4 week submission requirement for Trigger Exceedance Notifications.

This report is dated the 27th of February as this was the date the report was submitted and therefore the date of non-compliance.

A separate CAR form with a different date will be issued with regards the Initial Investigation Report submission.
