There are no emission limit values in the permit for emissions to sewer. This form is sent for information only.

Water Usage 1, 2018

Overall use compared with 2017 was reduced by about 4%, but the total volumes used have to be estimated due to the nature of the processes on site. However this is very encouraging as water use, using the corrected volumes, increased in both 2016 and 2017.

Energy 1, 2018

Energy usage has increased by more than 55% compared with 2017. This significant increase is in part due to other, non-permitted parts of the operation showing increased business.

Performance 1, 2018

No raw materials were used in 2018.

Waste disposal and/or recovery volumes were more than 75% higher than in 2017.

2018 SITE REPORT

There were several breaches of the DCWW Consent Limit for heavy metals in 2018. Effective remedial action has been taken and treatment methods and control have been improved.

There were no significant fugitive emissions, accidents, incidents or complaints in 2018.

The total amount of waste accepted on site was similar to 2017, but more of this waste was sent to landfill, hence the increase in the disposal/recovery volumes seen in form Performance 1.

Raw material use has been replaced where possible by the use of some wastes or treated wastes in other processes.
