The ESH Targets Overview for 2018 was received on 13<sup>th</sup> February 2019. The values in this report differ from those in the annual reports because this review refers to the whole site, whereas the annual reports only refer to the permitted installation.

The report is accepted.

All the objectives were met except for the reduction in total energy where the target was a 3% reduction and a 2.7% reduction was achieved.

There were significant reductions in water use (27%), waste generation (68%), disposal of waste zinc plating solution (19%) and in plastic cups for disposal (64%). The latter was achieved by introducing a financial incentive for people to use their own cup, rather than a disposable one and seems to have been very effective.

Continental can be very proud of these significant reductions in water use and waste generation.
