4. Details of our assessment

A Trigger Exceedance Notification report was received from Dwr Cymru on the 25th of July 2023 after the number of spills permitted was exceeded on the 16th of January 2023. Then an Initial Investigation Report was submitted on the 3rd of November 2023.

The length of time between the exceedance and the submission of the Initial Investigation Report means that the report arrived late and as such, is a permit breach. A warning is issued via this CAR form for this.

After saying the above, thank you for submitting the Initial Investigation Report and for all the work involved.

It's noted that you intend to carry out a detailed root cause analysis, optioneering, solution development and outline design by the 30th of June 2024.

Please provide an update on this planned work (or a Spill Reduction Plan with appropriate timescales) by the 31st of July 2024, i.e. within a month of your anticipated date of completion of the outline design etc.
