This is my third inspection in recent years. There has been considerable changes at the site and this needs to be reflected in the management system, which I believe is still referred to as the working plan. This is over 10 years old. An immediate update is required to reflect the current working conditions at the site.

As discussed in my previous inspection and CAR form there are a number of items in the permit that require compliance.

1. I have yet to receive monitoring records as a result of the sampling regime highlighted in condition 3.71 and tables 3.7b and 3.7b of your permit.
2. I also require a copy of the discharge consent which allows you to discharge those said Gully waste from the permitted area.
3. The interceptor inspection and maintenance records are also required and the consignment notes for the waste that has been removed from this interceptor should be forwarded to me within five working days of it being emptied.

I have scored you on the above items. I believe you have had plenty of time to resolve these issues. These were highlighted in the previous inspection.

- Please can you ensure only inert waste is stored on hard standing. All other waste must be stored on an impermeable pavement as Schedule 2 Table 2.1 of your permit.
- Can you confirm that your impermeable pavement drains to a sealed drainage facility.
- Finally the bunded area in the yard was visibly fractured and leaking. Please ensure this is rectified and in future minimise the amount and time material is stored in these secondary containment structures.
