4. Details of our assessment

Abril Industrial Waxes Ltd

The purpose of this Compliance Assessment Report (CAR) is to acknowledge a Natural Resources Wales site visit to Abril Industrial Waxes on the 12th December 2023.

The visit was instigated by an inquiry submitted to NRW by Abril regarding a potential new product and associated additional diamine usage. This visit was additionally used for introductions due to a change in Site Officer on the Part of NRW.

Introductions between Brigid Armstead (BA) and Abril Industrial Waxes Environmental Management Team members as BA will be the primary contact for this site on behalf of NRW.

Business updates received from the Abril team included an estimated timescale with full production of the new product by 2025. Specific details of the new production method are still under development in order to ensure all fumes are contained and environmental impacts controlled. The storage location of the diamine drums is also yet to be determined. Abril were advised that a variation application would be necessary for the new process.

Site walkover included a tour of the sifting and packing area, the reactors, the filters and the tank storage facility.

No non-compliances were observed during the inspection.
