4. Details of our assessment

Site Report

I (Environment Officer Gavin Dodd) arrived at IG Design, Penallta Industrial Estate on Thursday 12th October 2023 at 13:00 to conduct an inspection regarding a discharge of matter other than trade or sewage effluent to a stream (Permit Number AN0066901). As per the permit, the discharge was only to consist of uncontaminated surface run-off from roofs, yards, paths or roads. Site Engineering and Facilities manager Angelo Andriola was also in attendance.

The discharge point was inspected. The discharge entered an unnamed tributary of the Nant Cylla at the NGR specified in the permit (ST14089640). At the time of the inspection, clear water was flowing from the outfall and into the tributary. There was no odour to the discharge and the tributary did not have any discolouration. The inspection concluded at 13:30.
