4. Details of our assessment

On Thursday 7th December 2023 officers from Natural Resources Wales attended Dyfi Skips to undertake an inspection of the activities taking place under environment permit QP3494F. The visit was conducted by Gillian Coates, Hazardous Waste Regulation Officer, along with Luke Taylor, Waste Regulation Officer, and David Fowles, Waste Regulation Placement Officer. During the visit officers were accompanied by the site operator/Technically Competent Manager, Josh Jones.

The weather at the time of the visit was wet and overcast, with light rain.

Condition of the site

It was evident that there has been further improvement to the site compared to the previous visit, with a significant amount of clearance having taking place. Overall the site was clear and tidy.

Owing to the heavy rainfall experienced during recent weeks the hard standing areas of the site had started to deteriorate. However, Mr Jones stated that material, slate chippings from a local quarry, had been purchased to address this, which was already on site, pending a dry day to lay it.

There is evidence of Japanese knot weed at the bottom of the site adjacent to the railway. This appeared brown and withered. Josh Jones stated that Network Rail has been to treat it and would be returning to monitor and retreat if necessary.

Since the previous site visit, which was conducted in December 2022, Josh Jones has completed the CIWM WAMITAB qualifications to act as TCM for the site, evidence of which has been provided to NRW.

The following non-compliance was identified:

C2 - Management system and operating procedures (Permit Condition 1.4.4) - Action Only

The above permit condition states that '*Attendance of the Technically Competent Person(s) at the site shall be recorded in the site diary on arrival and departure*'. Officers requested to see the site diary with evidence of TCM attendance. It transpired that, whilst there was a record of the days when the TCM was not on site, the system did not record the date and time of when the TCM was on site to oversee operations.

Action - Update the site diary to correctly record when the TCM is on site. No deadline has been set for this action as confirmation has been received following the visit that this has been addressed.
