3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

You are non-compliant with your permit.

We are currently considering taking enforcement action against you for the non-compliance recorded above. We will contact you in due course.

4. Details of our assessment

This compliance form is due to the recent failure at your site in regards to suspended solids in the final effluent discharge. The permitted amount as per the permit to discharge

(AN0142702) is **30mg/l**, whereas the sample taken dated 05/12/2023 at 13:31 showed this to be **48.5mg/l**.

This is a non-compliance and as such, will need to be investigated further. With this in mind, as well as unaddressed actions from the previous compliance form dated 06/12/2023, please could you organise a suitable date in which we can attend site to carry out an audit with the appropriate people who have knowledge of the treatment works. Additionally, we would like more information as to why the failure occurred by the deadline listed in the tasks (19/01/2024).
