4. Details of our assessment

This report details a planned site inspection made on the 6th of December 2023 to Ty Mawr Farm Former Landfill, Newport, permit reference number EPR-AB3891ZU. Natural Resources Wales (NRW) Officer Chris BURGE and Enforcement Apprentice Mark O'GORMAN attended the Ty Mawr Farm Former Landfill site at St. Brides, Wentlooge, Newport, NP10 8SF for a routine site inspection at 10:15pm and met with Mrs Stacey SHERVINGTON. The weather was dry, cloudy, and cold.

SITE INSPECTION

At the time of the inspection the site was not operating due to the recent heavy rainfall and the material being too wet to process. During the visit Officers were shown a new machine the site has been trialling which will provide a better quality and cleaner product after processing than the current operation. There were no excessive / offensive odours and / or noise witnessed by NRW personnel during the site inspection.

Photo one shows a section of the trial equipment



The process involves the material being loaded into a hopper which then feeds into the machine (as seen in photo 1). The material is then washed and sorted into size order from sand to larger recovered aggregates. Any waste that is produced is taken off site to a permitted waste facility.

WASTE RETURNS

Waste returns have all been submitted and up to date. When checking the waste returns it appeared the site had accepted no waste, after raising this with the site operator it was discovered to be an admin error from a new member of staff, all waste returns have been re submitted and show the site to be within the correct limits of 75,000 ton per annum.
