This was a scheduled periodic site inspection.

The purpose was twofold;

- 1, To take the opportunity to meet a local councillor and member of the public who have expressed interests in the environmental issues posed by the site.
2. To monitor the running of the site as the regulator.

### Dust Complaint -

Site received a complaint about the levels of dust seen at the site from the neighbouring Dowlais Top village on 3rd July 2019 ref WIRS 19044531. The concerns were that the dust may contain asbestos. Site responded to the complainant and offered the reassurance that no asbestos was being received. There are measures in place to control asbestos liberation. NRW are satisfied with the measures in place at the site and accept the reasoned response that the dust seen was likely to be tyre pick up from the perimeter access tracks due to a long spell of hot dry weather. At the time of the inspection a water bowser was seen to be operating as a dust suppressant and minimal dust was seen to be picked up. NRW are satisfied with the measures in place to control dust and the sites level of response to the complaint.

### Site Tour -

The site tour offered a view of the whole site. As well as the dust suppressing water bowser, there were several loads being accepted into the current tipping cell. This was immediately tramped down. As a consequence, seagull activity was minimal. The soil treatment pad was seen to be operating with 3-4 windrows being treated. The pond from this area was higher than normal and due to be pumped down as per routine. No rats or vermin were seen. No insect populations observed. No odour was experienced, or dust seen. There was no windblown waste present around site. A dedicated member of staff was seen to be employed in collecting stray litter from the tipping face. The site was seen to be operating normally without any issues.

### Phase 7 sidewall construction-

Work on the phase 7 sidewall construction works had commenced from 12th July and is expected to take 10 weeks. NRW have raised several minor technical queries with the plans which need to be satisfied. Ongoing.

Next scheduled site inspection October 2019.
