This Compliance Assessment Report (CAR) has been issued in response to the submission of the Q3 (July - September) 2023 monitoring returns by Dunbia (UK) for activities at Teify Park Abattoir and Meat Processing Plant, Lampeter Road, Llanybydder SA40 9QE under permit number EPR-BV9683IH.

**Q3 2023 Monitoring Returns****Emissions to water - Q3 Water**

The returns for reporting of sampling and analysis of emissions to water (other than sewer) to emission point W2 for Q3 2023 (01/07/23 - 30/09/23) were submitted on 5 October 2023.

This data was sent within the reporting period, which is **compliant** with permit condition 4.2.3.

Based on the reports submitted by the operator, all other emissions at the monitoring points appear **compliant** with the specified emission limits over the Q3 reporting period.
