Measures taken, or intended to be taken, to stop the emission	Production started back up at 14:00 after a week long shutdown. Dust readings were initially high on start-up but settled to below permitted limits. However, an unscheduled stop occurred between 18:30 and 19:30, and then again at 23:00. As a result, there were only 14 half hourly valid averages for the relevant 24 hour period. The daily average value is therefore invalid (a minimum requirement of 43 valid half hourly averages are needed for a valid daily average in our permit) but a Schedule 5 has been prepared for completeness and transparency.
