Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

4. Details of our assessment

Quarterly Monitoring of Results- Q3 2023 (July – September).

Quarter 3 monitoring data for Brookhill Landfill Site, Pinfold Industrial Estate, Buckley, Clwyd, CH7 3PL was submitted to Natural Resources Wales in accordance with permit condition 4.2.2 on the 31st October 2023.

Monitoring of Emissions and the Environment

Monitoring has been undertaken in accordance with Condition 3.5 and Schedule 3 of the permit.

Landfill Gas

Methane and Carbon dioxide levels did not exceed the permitted limits in offsite monitoring boreholes during the review period.

It was noted in the report that oxygen levels greater than 5 % have been observed in gas wells across the site. These are being managed in accordance with the gas management plan.

Leachate Levels

Leachate level breaches over the 2m and 3m above base limits occurred in all cells apart from Cell 3 which remained compliant throughout the quarter. The maximum leachate rest levels, above the compliance levels, were as follows: Cell 1 (1.24 m), Cell 2 (0.27 m), Cell 4 (1.81 m), Cell 5 (1.35 m) and Cell 6 (2.62 m).

A **category 3** score has been applied against permit Condition 2.7.1 "For the following activities referenced in schedule 1, table S1.1 (A1.) The limits for the level of leachate listed in schedule 3 table S.1 shall not be exceeded".

Action 1: Continue to manage levels by extracting leachate from site.

Leachate Quality

Leachate quality is monitored monthly and has been reported as described by permit Condition 3.5.1(a) and Schedule 3.8. No permit breach has been identified.

Groundwater Levels

Groundwater levels were recorded monthly with levels reflecting seasonal trends.

Groundwater Quality

The sampling of groundwater was undertaken monthly as stated in permit Condition 3.5.1(c) and Schedule 3.9.

The following emissions limit breaches were observed, maximum measured concentration provided in each case:

GW2A: ammoniacal nitrogen **5.11 mg/L** compared to permitted limit of 1.7 mg/L, Chloride **106 mg/L** compared to permitted limit of 60 mg/L.

GW3A: ammoniacal nitrogen **9.13 mg/L** compared to permitted limit of 1.7 mg/L, Chloride **74.4 mg/L** compared to permitted limit of 60 mg/L.

GW4A: ammoniacal nitrogen **6.16 mg/L** compared to permitted limit of 1.7 mg/L.

A **category 3** score has been applied because of an ELV breach of ammoniacal nitrogen against permit Condition 3.1.5 "For the following activities referenced in schedule 1, table S1.1 (A1.) The trigger levels for emissions into groundwater for parameters and monitoring points set out in schedule S3.4. shall not be exceeded".

A **category 3** score has been applied because of an ELV breach of chloride against permit Condition 3.1.5 "For the following activities referenced in schedule 1, table S1.1 (A1.) The trigger levels for emissions into groundwater for parameters and monitoring points set out in schedule S3.4. shall not be exceeded".

No other breaches were identified.

Action 2: Continue to monitor trends. As per previous CAR forms and advice, consider varying the trigger limits for these boreholes.

Surface Water

Surface water data from P4 indicates that the permitted surface water emissions limits set for P2 have not been exceeded (no emission limits have been set for P4).

No other surface water samples could be obtained.

No breach identified.

Emissions to Sewer

The quality of leachate which was discharged to the Welsh Water sewage network was reported in accordance with permit Condition 3.5.1(g) Schedule 3.11. All parameters were compliant with the Welsh Water discharge consent with the exception of ammoniacal nitrogen.

Dust

Dust monitoring has been undertaken in accordance with permit condition 3.5.1(f). No breaches have been observed.

Reporting and Notification to Natural Resources Wales

A report presenting monitoring data for Q3 2023 has been received as specified by permit Condition 4.2.5.

A number of permit breaches have been identified within the quarterly report. Completed Schedule 5 notifications for permit breaches were received by NRW in line with permit Condition 4.3.1.

Excavation of Trial Pits

Trial pits were excavated within the area to the north of the site on the 11th September 2023. A report was to NRW for review on the 1st November 2023 with document reference 4849-CAU-XX-XX-RP-V-0300.A0.C1, the report has been submitted to the geosciences team at NRW for review. Findings will be discussed in a later compliance assessment report.
