4. Details of our assessment

Environment Officers from NRW visited St Asaph Sewage Works on 20/12/23. Officers conducted a visual inspection of the treatment process. Andy Garner, Operations Supervisor, Dwr Cymru was present.

In general the site looks to be in a good working condition. There are not any ongoing or outstanding issues that may impact the treatment of the effluent discharged. Officers checked on site paper records for daily activities and effluent analysis.

A query has been logged with NRW Permitting Team to check if the second discharge point (used if the river is high) should be mentioned in the permit, it isn't at present.

Following our inspection we have some further queries:

Please confirm the point the storm tank is full (Level in metres) and spills to the CSO.

Explain how the bifurification tank works and its connection to the the storm system. Include a diagram if possible. Is the bifurification tank additional storage to the storm tank or is that included in the 450cm³ mentioned in the Roe Parc CSO permit.

Is there a storm screen? If so where is it?
