### 4. Details of our assessment

#### Monitoring returns

Air emissions monitoring for the A1 stack from the air treatment system is required to be undertaken once every 6 months. Monitoring was undertaken on 5th June 2023 in accordance with Condition 3.5.1 (a) and results were submitted to NRW on 26th July 2023. Odour was reported above 1,000 ouE/Nm<sup>3</sup> limit and TVOC reported above 40 mg/Nm<sup>3</sup> limit.

A Schedule 5 Part A notification was received for these breaches of emission limits. Investigations into the breaches were inconclusive and as an action the site brought forward the next round of air monitoring, as detailed below, which were in compliance with the ELV's.

**Score:** (IR3A) Emissions to Air. Permit Condition 3.1.2. Schedule 3, Table S3.1. Non-compliance score C3

**Action:** No action. Resolution already implemented by operator.

Air emissions monitoring results for A1 from 28<sup>th</sup> September 2023 were submitted to NRW on 15<sup>th</sup> November 2023. All results were compliant and below the ELVs stated in accordance with Condition 3.1.2.

Bio-aerosol monitoring was undertaken in accordance with Condition 3.5.1(c).

Table S3.4 specifies limits for bio-aerosol concentrations as:

- Total bacteria (TB) - 1000 cfu/m<sup>3</sup>
- Aspergillus fumigatus (AF) - 500 cfu/m<sup>3</sup>

Results from 3<sup>rd</sup> November 2023 were submitted to NRW on 2<sup>nd</sup> January 2024. Bio-aerosol concentrations were compliant at all sampling locations during this monitoring exercise in accordance with Condition 3.1.2.

There were no discharges to sewer during the reporting period.

The efficiency of the biofilter was monitored in accordance with Condition 3.5.1(b) and measured at 99.3%.
