A site inspection was carried out following complaints regarding flies offsite and the receipt of a Part A notification from the Operator regarding high numbers of flies in the overflow lairage.

NRW observed higher than normal levels of flies in the overflow lairage. The fly catch bags around the perimeter of the site were also assessed and, with the exception of the one near the hedge by the site entrance, contained low levels of flies.

The operator advised that they had been unable to spray the previous weekend due to the adverse weather conditions but that spraying was due to be carried out the following day.

Since becoming aware of the issue the operator had ordered some new spray equipment with increased coverage, arranged for a pest control contractor to attend site on 7th May and for the remaining chambers of the overflow lairage to be emptied and sprayed with lavaside (this has now taken place). RPF are also considering cladding the side of the overflow lairage (to increase the surface area that can be sprayed) and it was recommended that this be discussed with Check Services.

Following the inspection the operator was requested to

- Assess the root cause of the increased fly numbers in the overflow lairage
- Review the frequency of emptying the overflow lairage
- Review the frequency of spraying the lairage
- Provide the findings of the assessment by Check Services
- Review the Pest Management Plan.

The build up of flies on site is in breach of permit condition 1.1.1, category 3. Please provide an update by 13 May 2019.

Since the visit the Operator has advised that the fly numbers on site have decreased.

Whilst on site NRW noted blood seeping out of a trailer near to the overflow lairage. This was then running across the yard onto an area of unmade ground from where it was seeping to ground. This is in breach of permit condition 3.2.1, category 3. There is also a potential for odours associated with this.

The Operator should ensure that all unsealed trailers storing material that may seep out, are stored in areas that would contain the spillage.
