### 4. Details of our assessment

This Compliance Assessment Report (CAR) form is being issued as a follow up to CAR\_NRW0042826 following a solids breach on the 24th of October 2023.

Since the breach you've carried out an investigation into the cause of that breach and come back on the 13th of December with a letter outlining the changes in polymer dosing and daily checks etc. Thank you for this letter you submitted. It was good to receive it.

In light of what you've said in your letter, we've decided that we would not pursue enforcement action any further following the breach on the 24th of October - apart from issuing a warning via this second CAR form.

However, you've said in your letter that you would look into purchasing equipment to carry out in house daily / weekly checks on solids and COD. It would be appreciated if you could provide an update on this and send us a copy of your analysis results as evidence that this is progressing and that the site is now compliant with its permit.
