4. Details of our assessment

On 6th December 2023 Eastman/Solutia submitted a Schedule 5 Notification to Natural Resources Wales informing them that there had been a discharge of surface water on 4th December 2023, partially during the "cease discharge" period, due to heavy rainfall in the preceding days. This had caused elevated levels in the storage system and so the surface water was discharged to the estuary to prevent the site from flooding.

The discharge was analysed and all parameters were less than their respective emission limit values. The risk to the environment was therefore minimal.

Due to the unforeseen nature of the incident and the minimal risk to the environment, no non-compliances have been issued.
