### 4. Details of our assessment

On Wednesday the 20<sup>th</sup> of December 2023 waste regulation officers carried out a routine unannounced inspection.

There was no activity on site during the visit . The main gate was locked and the site was secure. A small amount of waste was seen in the middle of the yard.

During the last inspection the site TCM informed officers that this site was due to be closed.

#### **Waste Returns**

Condition 4.2.2 states: "Within one month of the end of each year, the operator shall submit to the Environment Agency using the form made available for the purpose, the information specified on the form relating to the site and the waste accepted and removed from it during the previous year"

A review of the 2022 waste return submissions for permit number EPR-ZP3994FJ has been completed. No waste returns have been received by Natural Resources Wales. This has subsequently been scored as a C4 breach against the relevant permit condition.
