4. Details of our assessment

NRW Officer Shaun Rees met with John Cherry's PA Donna on the 14/11/23 at Graig, Dolfor to carry out an audit regarding the sheep dip permit. Thank you for your time during the visit.

Non-Compliances (recorded in summary)

Permitted activities - disposal period

As per permit - A maximum of 3 disposals may be made per annum to the Gorstey and a maximum of 3 disposals may be made per annum to the Stock Yard Fields.

During the audit, records shown that 4 disposals had been made to Gorstey and 0 to Stock Yard Fields.

General management

Written management system not followed at all times resulting in number of disposal visits per area being above permitted numbers.

As a result of this audit NRW have initiated a regulator permit variation to bring the permit into compliance with  [Position Statement 022](#)

- Reduce the spreading volume to 1.5 cubic metre per year of waste sheep dip (working strength)
- Remove the disposal area (SO 1103 8834) Gorstey
- Reduce the number of disposals to a maximum of once per year
- Update Table S1.1 activities within the permit.
