### 4. Details of our assessment

On 29 October 2023, Natural Resources Wales (NRW) received an OPNOT from Dwr Cymru Welsh Water (DCWW) stating that both pumps at Cardigan No 5 Sewage Pumping Station (SPS) had failed due to the submersion of the Non-return valve (NRV) chamber. It is believed that this was caused due to a combination of high tides and high river levels.

As a result of the flooding of the NRV chamber, both pumps experienced an electrical power failure, with one needing to be replaced and the other needing repair following the incident. Due to both pumps being taken off-line because of the submersion, this meant that the asset had to spill.

On 31 October 2023, this was recorded as an incident on the NRW system to allow the incident to be assessed in line with the relevant guidance.

Schedule 1 Table S1.1 (A2) of the permit, number BH0074503, states that the discharge of sewage in an emergency via the point of discharge is permitted if the sewage pumping station is inoperative in the even of an electrical power failure that is not as a result of the act or default of the operator, its agents, representatives, officers, employees or servants.

Taking into consideration the above licence condition and the circumstances behind the spill, NRW do not believe that the spill represents a breach of permit.
