4. Details of our assessment

BAE have previously requested permission to run trials using the proving oven to remove explosives residues from glass vials. CAR_NRW0034758 and CAR_NRW0040842 gave BAE permission to run these trials within a given time period, but they were never conducted. BAE have again requested Natural Resources Wales' (NRW) permission to run these trials in 2024.

Permit GB3239HT covers the destruction of these residues in the proving oven and the T1 exemption that BAE hold allows acceptance and treatment of the glass vials. Any emissions arising from the destruction of explosives are covered in the existing permit.

The T1 exemption for the treatment of glass expires in February 2027.

NRW therefore have no objection to BAE conducting these trials, as long as the treatment details previously received have not changed and the trial period does not extend beyond 31st December 2024. BAE will need to seek an extension of this permission should the trials extend beyond this date.

This permission may be withdrawn should the trials release any polluting or hazardous substances.

If the trials prove successful, BAE should apply to vary permit GB3293HT, adding the glass treatment as an activity in Schedule 1, Table S1.1 and EWC 15-01-07 to Table S2.1 in Schedule 2. The varied permit should be in place before the T1 exemption expires in February 2027.
