Notification of exceedance of permit condition 8 (a) (ii) which state:

The discharge shall not contain more than 15 milligrams per litre of Suspended Solids. The sample taken on 4th of November 2023 produced a reading of 17 milligrams per litre of Suspended Solids.

This is the 1st exceedance for Suspended Solids at this site within the last 12-month period: Based on the LuT and the site's sampling frequency, this result is classed as a LuT Exceedance/Failure.
