4. Details of our assessment

On 5th December 2023 Natural Resources Wales (NRW) received a Schedule 5 Notification from AB InBev UK Ltd informing them that the emission limit value (ELV) for Total Phosphorus had been breached at the Final Effluent Sample Point ST 4369 8494 on 4th December 2023.

The ELV in question was introduced, along with others including Total Nitrogen, in the updated Permit V008 on 8th March 2022 and came into force on 4th December 2023. These 'new' ELVs arose following the publication of the revised Best Available Techniques (BAT) Reference Document (BRef) for the Food, Drink and Milk Industries. The Operator was informed of the intention to review and update their Permit in line with this publication on 27th April 2020.

Results for both Total Nitrogen (TN) and Total Phosphorus (TP) were submitted to NRW, as previous discussion had indicated a risk to both ELVs. At the time of the notification on 5th December the TN ELV had not been breached.

Discussions between NRW and the Operator indicate there is budget available to make improvements to plant to ensure consistent compliance with the new ELVs during 2024. In addition to this communication has been made to look at the options around utilising alternative methodology, such as mass load, when understanding the environmental impact of the estuarine emissions of the final effluent sample. As part of this work it is currently estimated that the environmental impact of the recorded exceedance are likely to be in lower or Minor category and are recorded as such;

1x Cat 3 minor – Potential to have a minor or minimal impact or effect on the environment, people and/or property.

If AB InBev UK Ltd need more time to reach a lasting solution to this problem then NRW are likely to be amenable and may be prepared to suspend non-compliance scores for certain emission points while this work is completed. However, NRW must still be formally notified of any ELV exceedances during this time.

Action: AB InBev UK Ltd to bring their emissions within the ELVs. They should also ensure that their testing methodology is to the standard specified in their Permit whilst continuing to monitor all parameters listed and notify exceedances.
