4. Details of our assessment

Following a request from David Jones at Powys County Council, I attended the site as planned on the 18th December, the weather was very wet with heavy rain throughout.

On arrival we discussed the layout and history of the site and walked-through the process

from start to end. There was no sign of any problems with the treatment or discharge.

As discussed prior and during the visit, the official discharge point appeared to be some distance from the final reed bed and has no functional method for calculating discharge volume/rate. Several options were discussed on-site, with it being agreed the final decision would be made in consultation with Permitting colleagues, though preference was for as near to the initial reed bed/bag filters as possible for ease of installation/maintenance.

We also discussed the potential for permit variation, given the ongoing review NRW is conducting, as well as in relation to the volume of the permitted discharge - which appears to be far higher than any discharge in recent times from the site. At this stage it was decided to avoid any variation where necessary, instead agreeing a discharge point for flow monitoring by other means.
