4. Details of our assessment

Introduction

Celtic Chemicals Ltd (CCL) is a privately owned company who carry out chemical dissolution and packaging; powders blending and repackaging. The chemicals are stored onsite and distributed to customers. The company occupies several light industrial units within the Kenfig Industrial Estate.

Scope

The following monitoring returns and reports have been assessed within this Compliance Assessment Report (CAR):

- Environment Agency Form L1 - 2023

2023 Annual Submission

The reporting form (referenced L1) was submitted by the Operator on the 5th of January 2024, the form details informative requirements set out by NRW within permit condition 4.2.1.

The information was submitted within the agreed reporting period (31 days), which is **compliant** with permit condition 4.2.1.

Following assessment of the annual report, the subsequent observations were noted:

- The annual submission contained all the required information in accordance with permit condition 4.2.1
- An ISO14001 accredited Environmental Management System (EMS) is due to be implemented within 2024.

- Electricity and gas usage is below the threshold for Low Impact Installations (LII).
 - Additional solar energy installations are planned.
- Plans to extend the production operations into Unit 20 will commence in Quarter 1 (Q1) 2024.
 - Potential requirement of a permit variation, dependent on proposed usage of the new commercial unit.

Action: If required, apply for a permit variation; increasing permitted area to include the additional commercial unit.

- Progression with dedicated water treatment plant (WTP), in partnership with Axium Process Ltd.

Action: Update NRW in the event of any significant developments with the WTP project.

- A significant volume of wastewater has been removed from Site by a licenced waste carrier on 7th September 2023.
 - Until the completion of WTP, regular wastewater removal events are required to prevent large volumes of wastewater from accumulating onsite.
