This Compliance Assessment Report (CAR) has been issued in response to the submission of the Q4 (October - December) 2023 monitoring returns by RWE Generation UK plc for activities at Pembroke Power Station, West Pennar, Pembroke, Pembrokeshire, SA71 5SS under permit number EPR-DP3333TA.

Q4 2023 Monitoring Returns**Releases to water** - *Water 1 (10/11/11)*

The returns for reporting of sampling and analysis of emissions to water (other than sewer) for Q4 2023 were submitted on 12 January 2024.

This data was sent within the reporting period, which is **compliant** with permit condition 4.2.3.

Based on the reports submitted by the operator, all other emissions at the monitoring points appear **compliant** with the specified emission limits over the Q4 reporting period.

Releases to air - *IED/LCPBREF CON2 (Gas turbines)*

This data was submitted on 12 January 2024 for LCP286, LCP382, LCP383, LCP384, and LCP385.

This data was sent within the reporting period, which is **compliant** with permit condition 4.2.3.

Releases to air - *IED/LCPBREF PM1*

Periodic monitoring results.

Based on the reports submitted by the operator, emissions at the monitoring points for Nitrous Oxide (NO_x) and Carbon Monoxide (CO) appear **compliant** with the site's specified emission limits over the Q4 reporting period.
