This Compliance Assessment Report (CAR) has been issued in response to the submission of the Q3 (July - September) 2023 monitoring returns by Materials Recovery and Energy Centre for activities by Neath Port Talbot Country Borough Council (*the operator*) at Crymlyn Burrows, Swansea, SA1 8PZ under permit EPR-BJ5775IF.

This data was sent within the Q3 reporting period, which is **compliant** with permit condition 4.2.2.

Emission point A2 is not connected to any plant equipment. As the Waste to Energy Plant has been decommissioned in 2013, all emissions to air have been submitted with NIL result.

Based on the reports submitted by the operator, all other emissions at the monitoring points appear compliant with the specified emission limits over the Q3 reporting period.
