Q4 2023 Monitoring Returns

4.2.3 of the environmental permit states:

Within 28 days of the end of the reporting period the operator shall, unless otherwise agreed in writing by Natural Resources Wales, submit reports of the monitoring and assessment carried out in accordance with the conditions of this permit, as follows:

- a) in respect of the parameters and emission points specified in schedule 4 table S4.1;
- (b) for the reporting periods specified in schedule 4 table S4.1 and using the forms specified in schedule 4 table S4.4; and
- (c) giving the information from such results and assessments as may be required by the forms specified in those tables.

Emissions To Air

The returns for reporting of sampling and analysis of emissions to air for Q4 2023 were submitted on 21 November 2023.

This data was sent within the reporting period, which is **compliant** with permit condition 4.2.3.

Based on the reports submitted by the operator, all other emissions at the monitoring points appear **compliant** with the specified emission limits over the Q4 reporting period.
