You are non-compliant with your permit.

At this time, we are issuing you with a warning for the non-compliance recorded above. Warnings may influence future enforcement response for continued or further non-compliance.

This statement does not stop us from taking additional enforcement action if further relevant information comes to light or offences continue.

4. Details of our assessment

A site inspection was undertaken on Wednesday 17th January 2024. The purpose of the inspection was to confirm the status of the site as non-operational and to assess whether site security was sufficient. Natural Resources Wales records indicate that the site has been non-operational in recent years.

Operational Status & Site Security

The Environmental Permit for the site (ref: EPR/FP3498FP) is still registered to Gilcrest Yard, Nevill's Dock, Llanelli, SA15 2NE.

At the time of the inspection, the site was not operational and there was no staff presence on site. There was no waste, plant & equipment on site and it appears that the site has been vacated by the permit holder/Operator.

The site, however, was open and easily accessible. Current site security measures can not prevent unauthorised entry and the site is not secure. Although there is no waste on site, the site is at risk of being subject to unauthorised access and illegal activities such as fly-tipping and fires. There was evidence of small-scale fires and illegal activity (littering, fires, burning of waste) present during the inspection.

A non-compliance was recorded against Condition 1.1.1 (a) of the Environmental Permit (Category 3 - Minor)(Ref:D1)

In periods when the site is non-operational, the site must be kept secure to prevent unauthorised entry and activity.

Our records indicate that you have not submitted quarterly Waste Returns since July 2016. Although the site is not operational, you must still submit Waste Returns confirming a 'nil' input/output.

A non-compliance was recorded against Condition 4.2.2 of the Environmental Permit (Category 4 - No Impact)(Ref:G4)

Environmental Permit Surrender

It is noted that the site is not currently operating, however, you are still required to submit Waste Returns information and pay annual subsistence fees. If you intend to cease operations permanently, you may wish to consider applying to surrender your Environmental Permit.
