This compliance report details the partial site surrender inspection conducted by Natural Resources Wales (NRW) Officers on 21 December 2023 at TXO Systems Limited - Permit number EPR-

AB3297TQ

Officers Carla CURTIS and Jodie BASKERVILLE attended the site at 11:30 to complete a partial surrender compliance inspection. Site Manager Chris Hoskins was present and accompanied Officers around the permitted area they wish to surrender. Weather conditions were mild, overcast and windy at the time of inspection.

GENERAL OBSERVATIONS

The unit is now occupied by a business called Endurance vehicle solutions. We met the manager, James Mulligan, who said they have been at the premises for approximately 4 years where they provide a range of contract hire and rental solutions, tailored for operators of specialist commercial vehicles, and include Road Sweepers, Gully Tankers and Hook Loaders.

The unit was very clean and tidy and there was no sign of any pollution or waste.

I am satisfied that the site has been returned to a satisfactory state and based on this visual inspection have no objections to the surrender of this permit.
