4. Details of our assessment

Natural Resources Wales senior industry and waste regulation officers Carter Shone and Paul Challender visited Solutia UK Ltd on the 16th of January. This was a pre-arranged familiarisation visit and site inspection accompanied by the site caretaker.

General management

The Groundwater and Stormwater Storage Facility is well run with the levels being closely monitored and maintained with alarms set for out of hours monitoring. Preventative maintenance has been carried out on various pieces of equipment including the valves leading to the discharge point. The officers were given an in-depth tour of the facility including the carbon filters and testing points.

The site

The majority of the site was clean and tidy.

The site has recently removed its high voltage connection and therefor is in the process of decommissioning its two transformers. One of the transformers has already been decommissioned and the waste oil collected into 4 barrels which sit next to the transformer on a pallet.

This has resulted in a category 3 score against permit condition 3.2.3 under compliance criteria (IR3B) Emissions of substances not controlled by emission limits. *'All liquids in containers, whose emission to water or land could cause pollution, shall be provided with secondary containment'*.

Score: IR3B – Emissions of substances not controlled by emission limits. Permit Condition 3.2.3. Compliance Score C3.

Action: Provide secondary containment for waste oil.

No odours were noted during the inspection

No offsite noise was noted during the inspection.
